

**OPERATIONAL SAFETY INSTRUCTION**

ATC Recognised Call-signs

It is the responsibility of all employers to ensure that relevant OSIs are brought to the attention of their staff. However, individuals remain responsible for their own actions and those who are in any doubt should consult their Supervisor or Manager.

1. INTRODUCTION

The purpose of this Operational Safety Instruction is to outline the recognised call-signs that are authorised for radiotelephony communication with ATC. These callsigns are applicable to 'M' and 'R' driving permit holders as well as personnel authorised to operate on foot on the manoeuvring area.

Operators who require access to the manoeuvring area must have a recognised call-sign for communication with ATC. Airside Operations share the list of approved call-signs with ATC, who replicate it in their instructions. A list of call-signs that have been issued to approved users of the manoeuvring area can be found below.

2. APPROVALS PROCESS FOR CALL-SIGNS

Requests for changes to the approved callsigns list must be directed to the Airside Operations team at airsideops@bristolairport.com.

If temporary call-signs are required at short notice, requests should be directed to the duty Airside Operations Officer on 07712 792235, who will allocate a call-sign and advise ATC.

3. RESPONSIBILITIES OF CALL-SIGN OPERATORS

- a) Where call-signs are allocated to a specific vehicle, they must be displayed in the vehicle cab within clear view of the driver.
- b) Only the call-signs marked with an 'XX' are permitted to operate additional numerical callsigns e.g. Ops 1, Ops 2 etc.
- c) Operating companies must ensure that the same call-sign is not issued to more than one individual or vehicle simultaneously to prevent confusion on the airfield.
- d) Individuals without a recognised call-sign should not operate on the manoeuvring area.
- e) Pedestrians operating on the manoeuvring area should advise ATC on their initial call that they are operating 'on foot'.
