INTRODUCTION OF INTERMEDIATE HOLDING POINTS AND EXTENSION

**OF TAXIWAY ZULU** 

An Airside Information Notice (AIN) will be issued to notify airfield users of pertinent operational or administrative information, such as a general or routine reminder of airfield procedures/instructions, the promotion of safety campaigns and changes to airfield infrastructure, signs or markings. It is the responsibility of all employers to ensure that relevant AINs are brought to the attention of their staff.

#### 1. OBJECTIVE

To announce the planned introduction of two new intermediate holding points with stopbars and the incorporation of the cul-de-sac south of stands 18-20, into taxiway Zulu.

This work has been completed as part of the wider Eastern Apron Stand construction project to construct stand 17 (to be available for operational use from April, further information to be published on this).

### 2. SCOPE

This notice is relevant to all manoeuvring area operators, including aircrew and airfield drivers.

### 3. INFORMATION

From 0600 on the 23<sup>rd</sup> March\*, holding points Z3 and Z4 are planned to become operational, and the cul-de-sac to the south of stands 18-20 will become incorporated into taxiway Zulu.

Z3 and Z4 are bi-directional and switchable stopbars and shall be utilised to manage the traffic flow on taxiway Zulu.


\*NB There will be a final Go/No-Go call at 0300 on 23/03/24. If the transition date is postponed, one of the following alternative dates will be confirmed: Overnight on Tuesday 26<sup>th</sup>, or Wednesday 27<sup>th</sup> March.

If the implementation is successful on Friday night, NOTAM closures for Tuesday and Wednesday will be cancelled. A NOTAM will be published to advise of the revised layout, until this becomes live in the AIP from the 18<sup>th</sup> April.

## 4. AIRCRAFT PUSHBACKS – STANDS 18-20

Aircraft will be instructed to push back directly into taxiway Zulu once the cul-de-sac has been incorporated, as per the table below:

Aircraft will be given taxi clearance from the TRP, either turning left for a runway 27 departure or straight ahead for a runway 09 departure.
