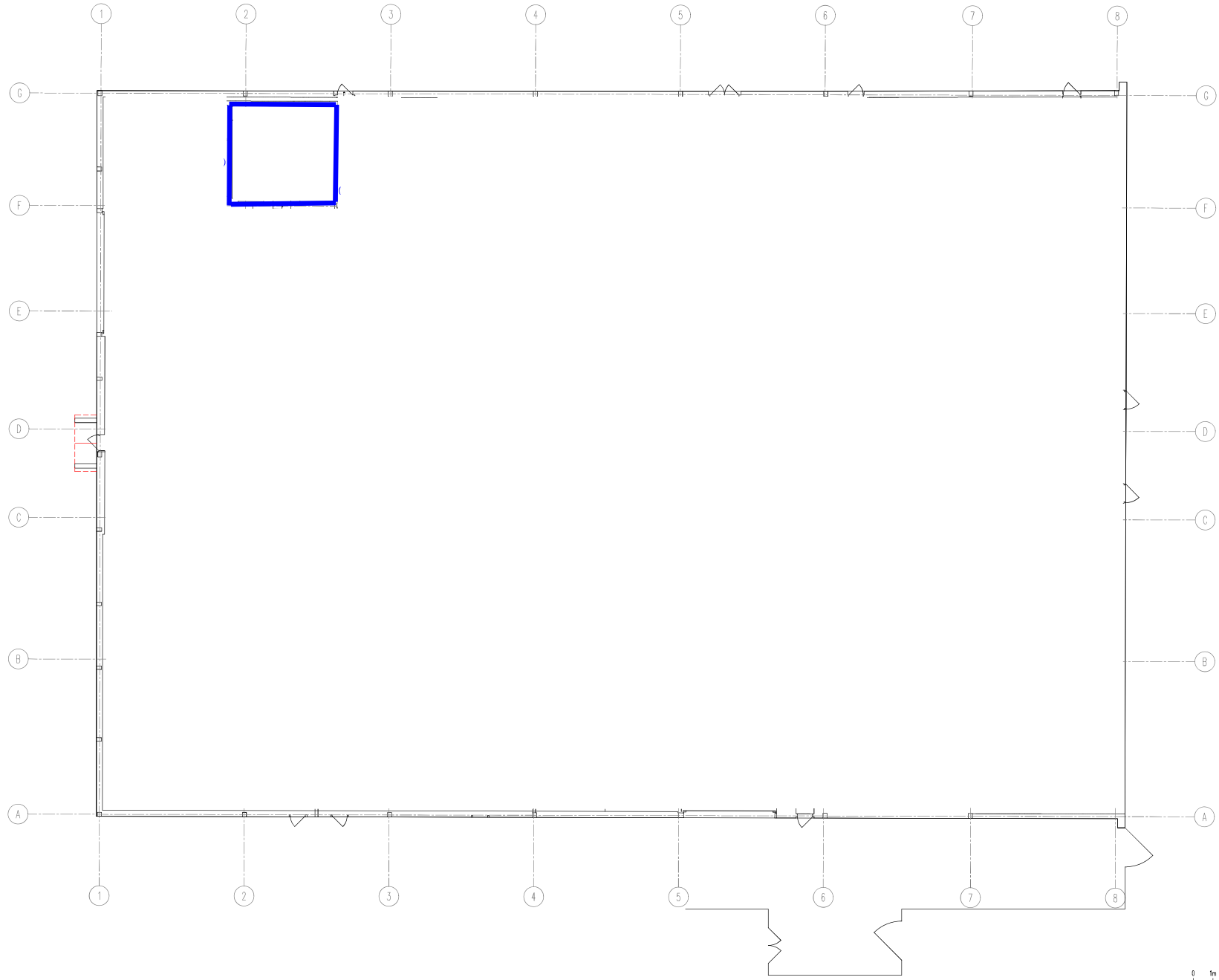




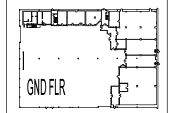
Blue Shed - Ground Floor

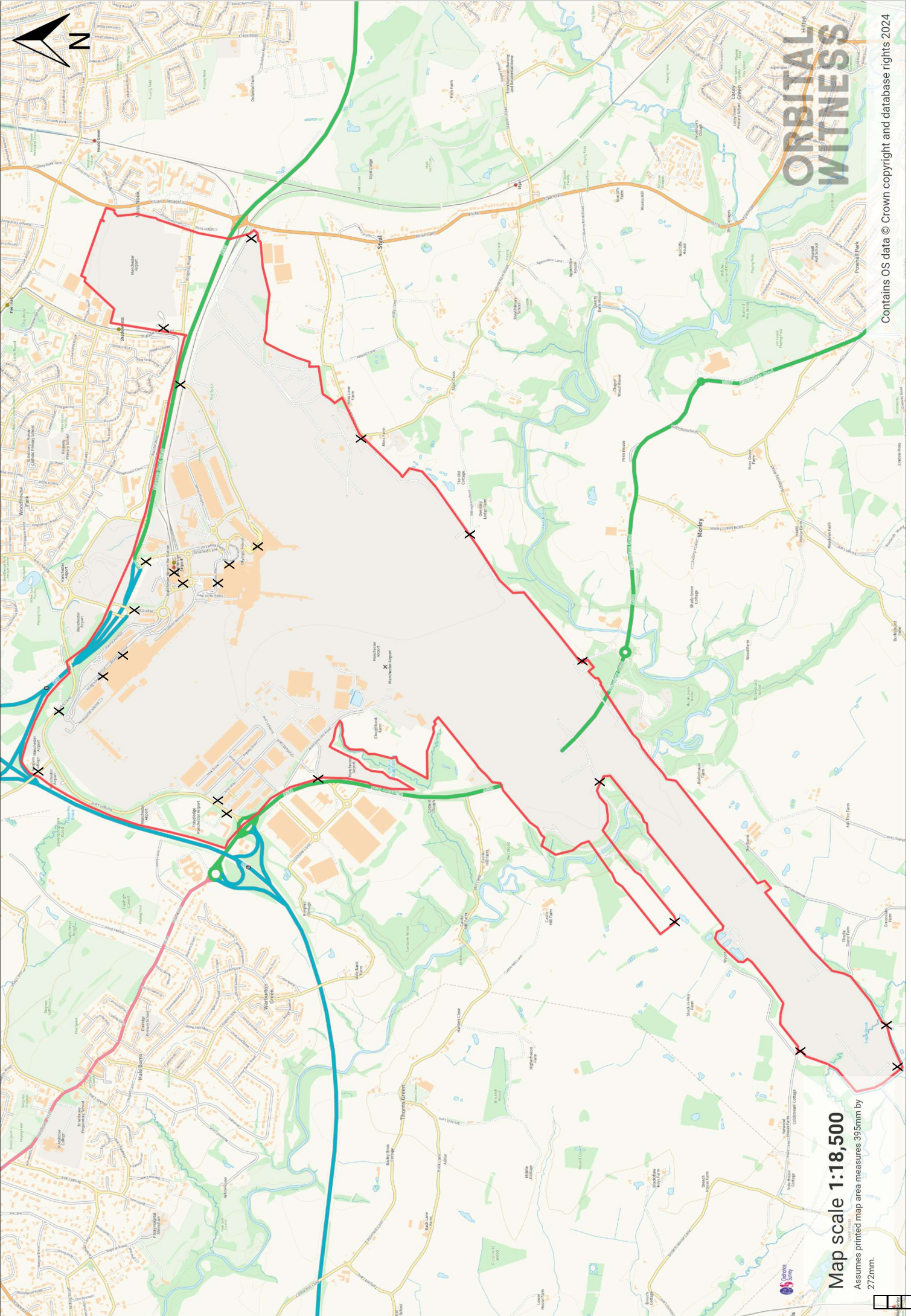

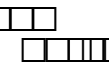
Injunction Area

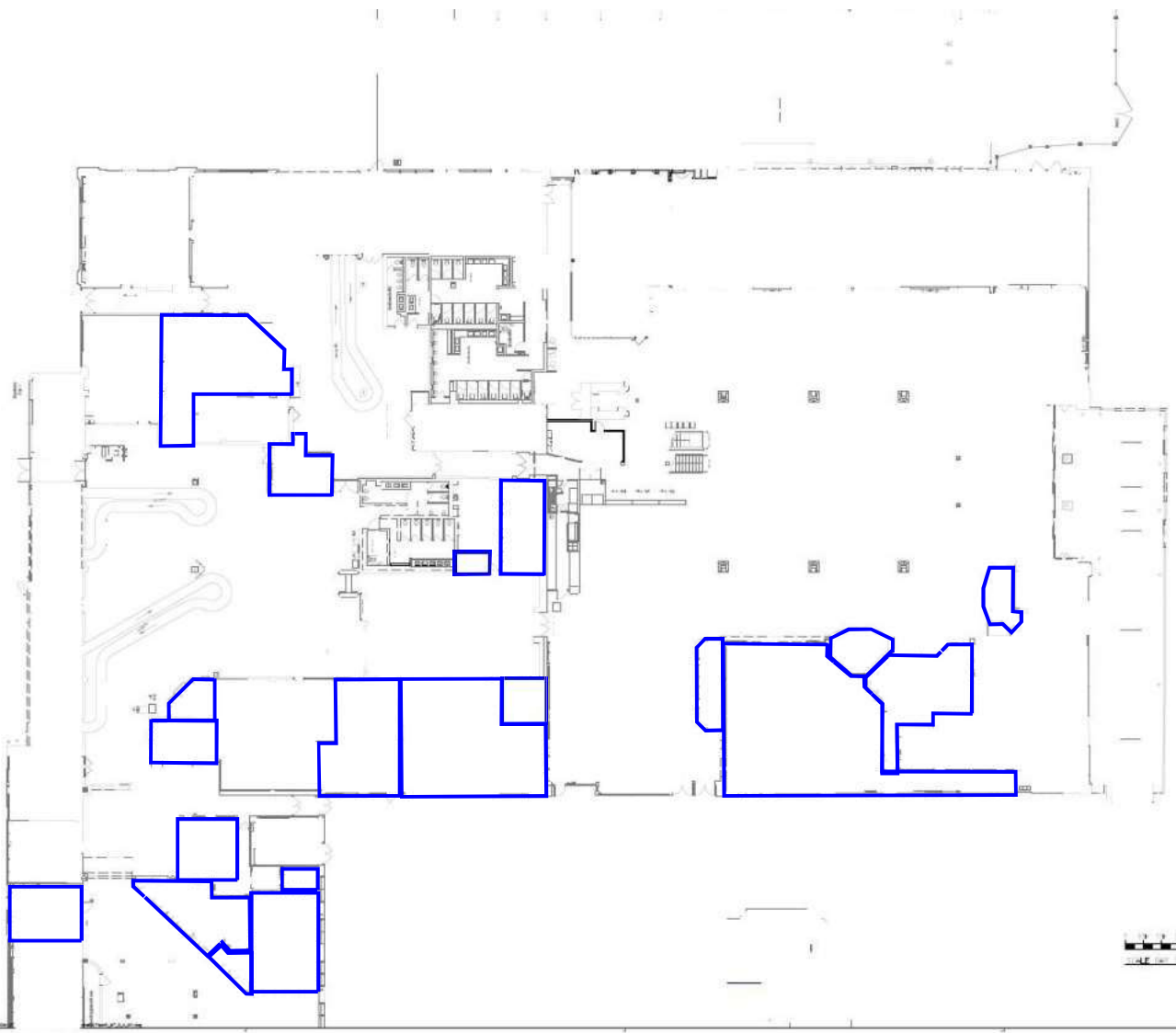

Main Terminal - Ground Floor

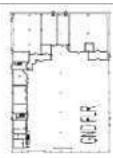


Blue Shed - Ground Floor

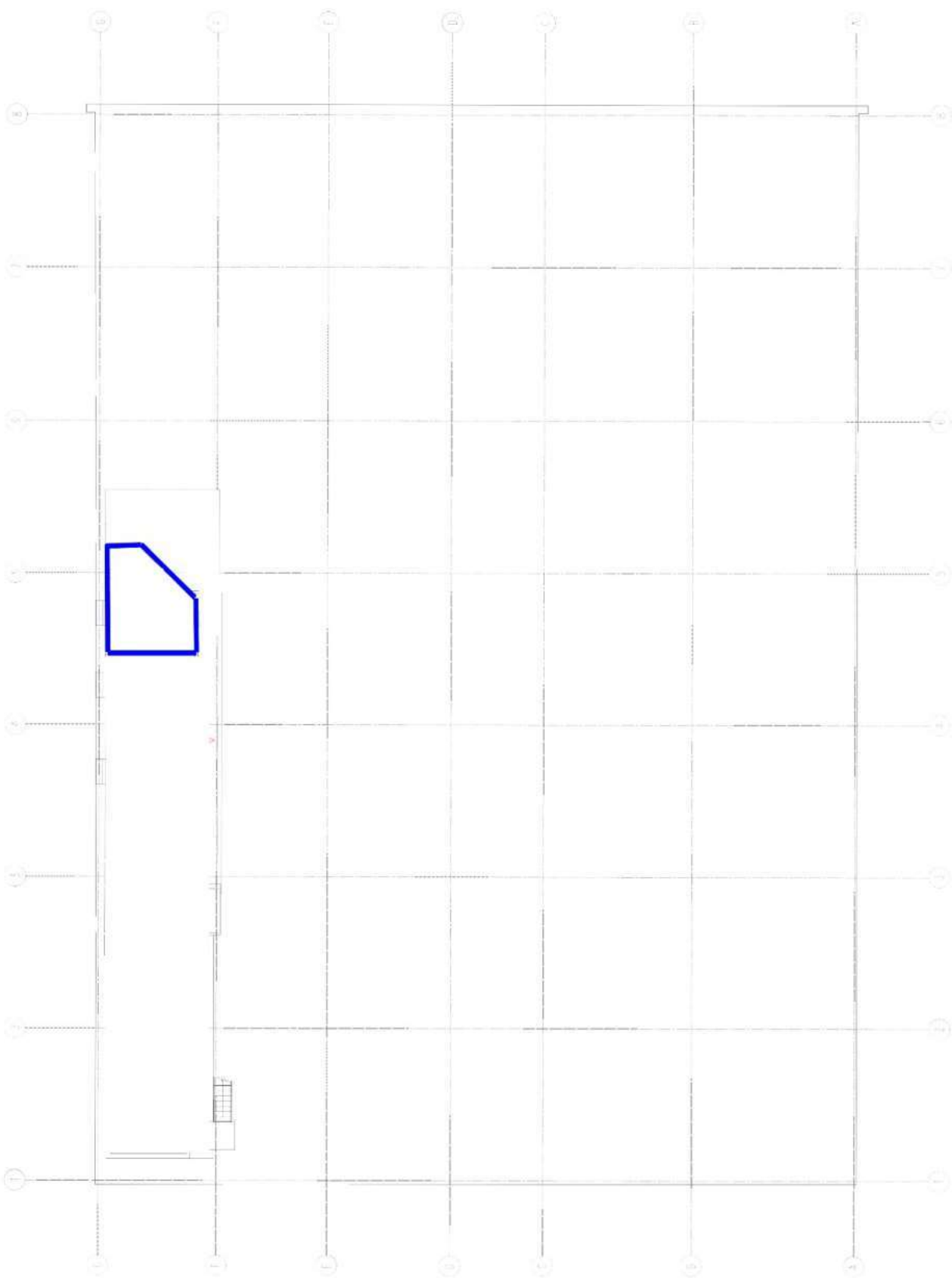

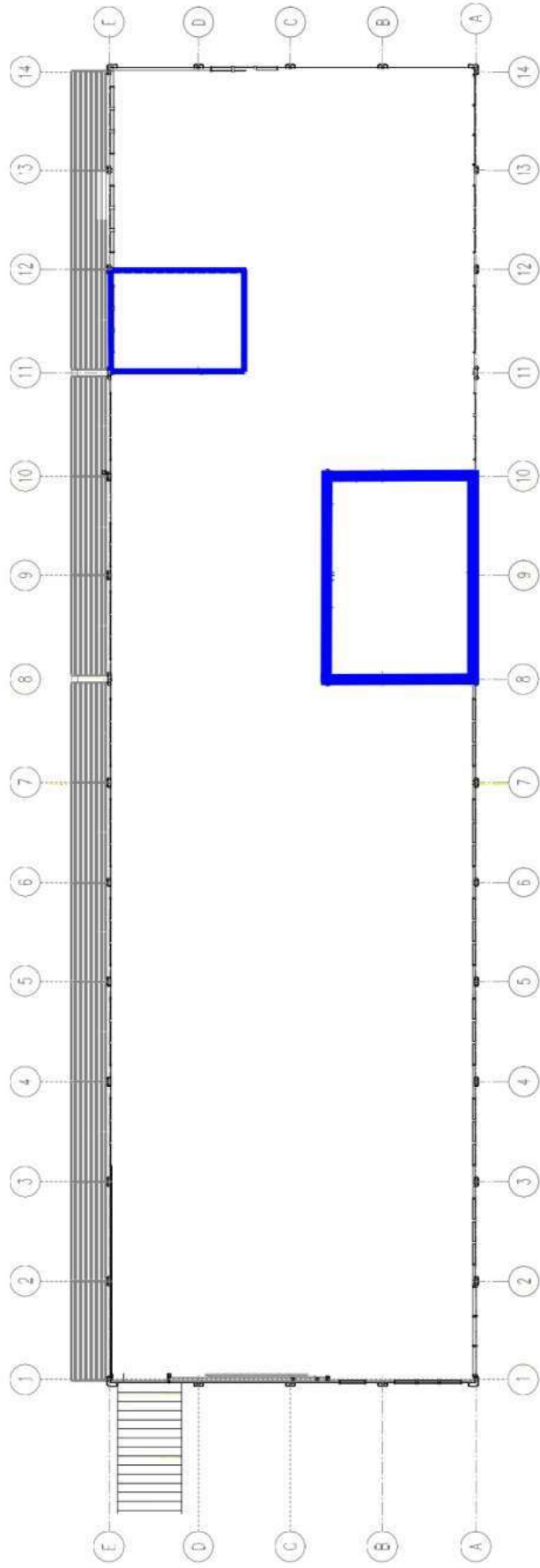

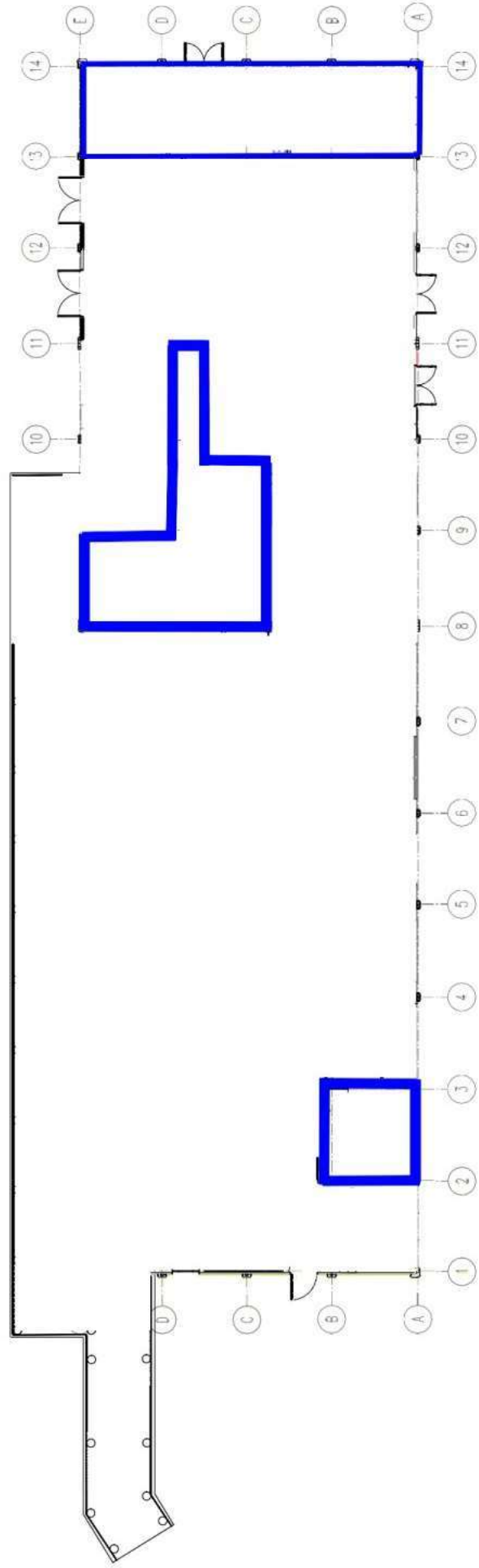


Plan 7

Jet Centre - Ground Floor



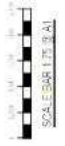
Jet Centre - First Floor

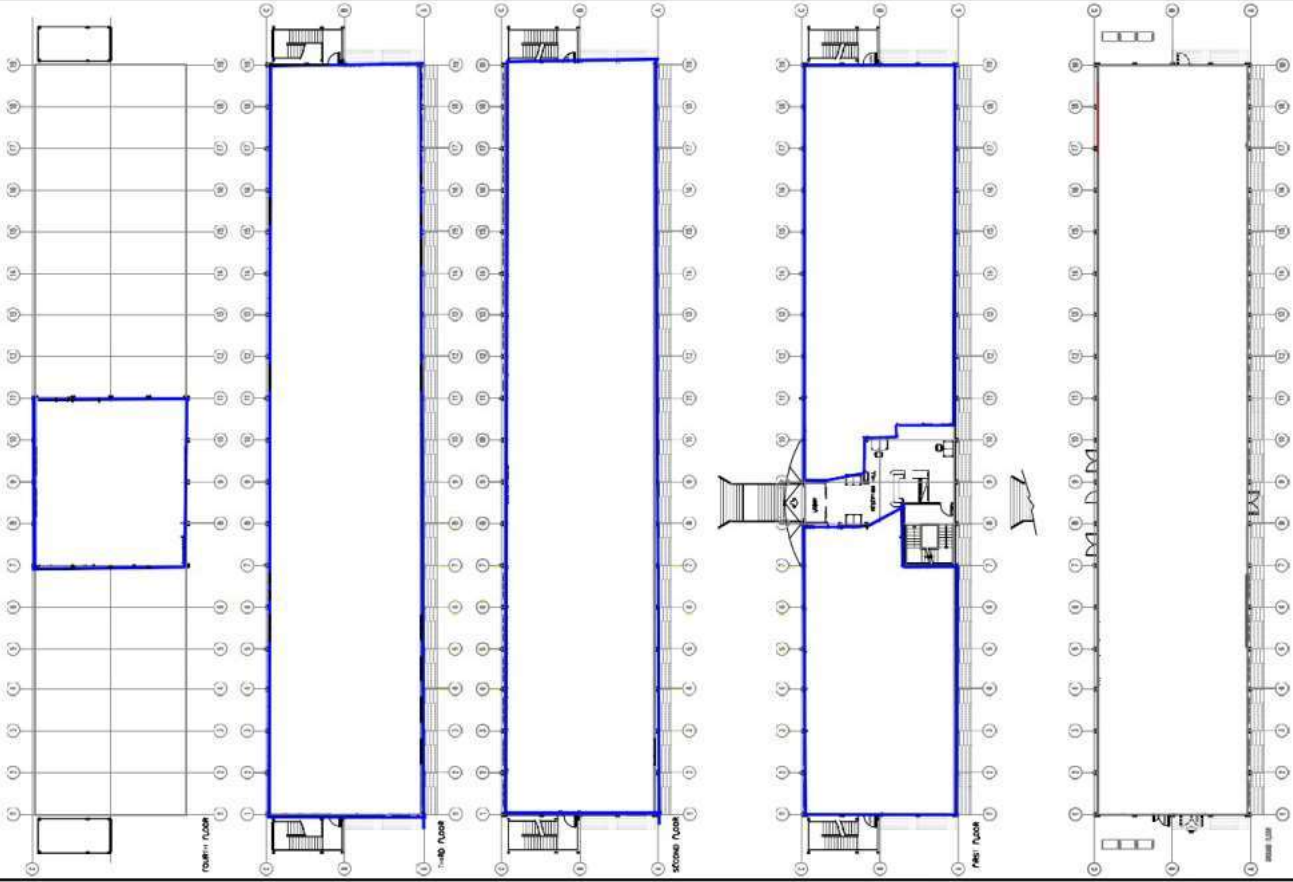

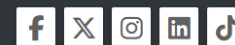
